1. Policy Statement

The Australian Islamic College Adelaide is committed to providing an environment where students feel proud to attend the College. The wearing of school uniform is therefore compulsory for all students. Our Board and school administration consider that wearing a uniform encourages pride in our school and helps to build within students a sense of belonging to a defined school culture, and responsibility for the representation of the school and thereby of themselves. It also helps both students and parents avoid competitiveness in clothing attire and ensures that the health and safety of our students is paramount.

2. Scope & Responsibility

This Policy applies to all students.

3. Policy Details

3.1 Implementation

The Uniform Policy is relayed as part of our regular communication through newsletters, assemblies, home group or class teacher reminders, parent meetings and school activities. It is also reinforced by teachers and administration who will remind students who appear with inappropriate or incomplete school uniform and will follow through with consequences where the policy is not adhered to deliberately.

- Students are required to wear the official school uniform on **all** school excursions (unless otherwise notified).
- Students are required to wear the school uniform when representing the school out of school hours and outside of the school premises.
- Wide-brimmed school hats must be worn in Term 1 and Term 4 during outside play activities.
- Clothing should be clearly labelled with names to ensure lost items can be returned.
- Reminders will be sent to parents when students do not abide by the school Uniform Policy and students may be sent home for repeat offences.
- For shirts/blouses, hijabs, pants and school dresses, students must purchase two to ensure uniforms are cleaned regularly as there is no excuse that 'it is in the wash'.

3.2 Exemptions

The Principal may exempt students from the dress code (section 3.6) upon written request from parents. Grounds for exemption are:

- Medical – The student has a condition such as allergies or disability that would prevent the wearing of the uniform. This must be accompanied by a medical certificate and alternatives will be negotiated.
- New or itinerant students (for a period of 2 days if uniforms are out of stock).
- Any other grounds that the Executive Principal deems sufficient.

3.3 New Uniform Transition

The College's current uniform was implemented in 2019. It is expected that all students will already have effectively transitioned to this uniform, unless there has been an ongoing shortage of supplies.

3.4 Financial Hardship

Where financial hardship impacts on the purchase of uniforms, it is recommended that families approach the College Administration so that supports may be implemented.

3.5 Uniform Shop

The uniform shop located in the back carpark of the school is open and available for student and parent access on Wednesdays from 8.30am to 11.30am and 1.30pm to 4.30pm. Any changes to the timing due to staffing, Ramadan or school holidays will be provided to parents through SMS/email.

3.6 Uniform Dress Code

Girls Uniform

Girls PE Uniform – Reception to Year 12
Navy blue long-sleeved polo with logo Navy microfibre loose track pants Sports shoes – any colour
Girls Additional Items – Year 11 & 12
Year 12 Special Jacket (order only) Navy chiffon hijab (to be outsourced)

Boys Uniform

Boys Uniform – Kindy / Reception
Navy blue polo top (long sleeve or short sleeve) Grey Jazz pants Bucket hat with logo Sports shoes – any colour
Boys Uniform – Years 1 to 12
Blue shirt with logo Grey charcoal trousers Bucket hat with school logo Navy or black socks Navy jumper with logo Navy jacket with logo Black leather closed in school shoes
Boys PE Uniform – Reception to Year 12
Navy blue polo (long sleeve or short sleeve) Navy microfibre track pants Sports shoes – any colour
Boys Additional Items – Year 12
Year 12 Special Jacket (order only)

3.7 Accessories not permitted

The following accessories are not permitted:

- Body piercings (however, girls may wear a single pair of discrete studs or sleepers in their ears, which should not be seen, and one discrete stud on one side of the nose)
- Wristbands, unless in line with school fundraising or activities
- Nail polish and acrylic nails
- Baseball caps
- Make-up – students will be requested to remove make-up
- Hooded jumpers / non school jumpers, non-school jackets and non-school trackpants

Earrings (with above restrictions) and watches are the only jewellery permitted to be worn in the school.

3.8 Boys Hair

- Boys hair should be short, not layered and with no fades, lines and designed carved in.
- Boys may have long hair, but not below the shoulder and must be all one length.
- Hair should be kept neat and tidy.
- Islamically appropriate hairstyle.

The following hairstyles are not permitted:
